# Australian Technology Organisation (startup or small-to medium-sized business)

The Technology Commercialisation Challenge (TCC), part of the India-Australia Renewable Energy Partnership, is funded by the Department of Climate Change, Energy, the Environment and Water (DCCEEW). TCC brings together India's growing renewable manufacturing capabilities with Australia's leading R&D expertise.

Under the TCC, research and industry stakeholders will be supported in pursuing collaboration and technology development, aiming to establish formal relationships between Indian industry and the Australian research sector, and solving renewable manufacturing challenges.

## Who should participate in the Challenge

This is a facilitated industry-research opportunity, to develop and support relationships between Australian Research Organisations or Australian startups and small-to medium-sized enterprises (SMEs) with Indian renewable manufacturers in:

- Solar photovoltaics
- Battery technologies
- Hydrogen technologies
- Associated technologies that support other key areas of the [India-Australia Renewable Energy Partnership](#).

Applications are currently open from Australian Research Organisations and Australian startups and small-to medium-sized businesses (SMEs) to participate in the Challenge.
