

"thought it prudent at this time to also follow up on a December 2013 story we published regarding an investigation involving the alleged penetration of the CSIRO by an alleged Chinese spy. The AFP was investigating the matter and we understand a mutual assistance request was lodged with the French Government, as the suspect is understood to have fled there.

Has the AFP made any headway on this investigation? Has anyone been questioned? Or is it still on-going?"

At this time, AFP media have not formulated a response, however (and I was only advised of this, this morning) they may respond advising the media outlet that the investigations has been finalised and that there was no indication of espionage. Once I have been advised by our media team regarding their response I can pass it to you both.
